We have been chosen once again by Ufton! We have been invited to send a group of children on a residential programme to Ufton court in Reading, Berkshire.

You are being given the chance to apply for a place for your child. Ufton Court is an innovative charity that aims to support schools in giving children a passion for



history and the outdoors. At Ufton Court, they give children the freedom to explore and discover. The previous year 4 class that went on this programme saw academic progress and had a great time. Social skills, problem solving and confidence increased.

Ufton court is a <u>year-long three-part programme</u> that challenges and inspires learning outside the classroom. From the exceptional house and grounds in Berkshire, they aim to raise aspiration and attainment of all children. They engage and challenge young people through physical and mental activities and embed new skills into their lives. They focus on increasing children's confidence and return young people to school physically and emotionally equipped to take advantage of opportunities and manage their emotions.

The residential programme consists of 3 separate 2 night camps on the following dates:
